## Information of the directors' remuneration for fiscal year 2020

The Company stipulates a clear and transparent remuneration policy for the Board of Directors and the Subcommittee. The remuneration is at an appropriate rate comparable to that of the same industry in the same size of business and is suitable for the duties and responsibilities of each director. The directors assigned to perform the duties in the Subcommittee are entitled to receive additional remuneration as a result of the increase in responsibilities. The Remuneration and Nomination Committee will consider the structure and composition of the preliminary remuneration to propose to the Board of Directors Meeting for consideration before proposing the Annual General Meeting of Shareholders for approval.

The Board of Directors agreed upon the proposal of the Remuneration and Nomination Committee and deemed it appropriate to propose to the Annual General Meeting of Shareholders to consider and approve the remuneration for the Board of Directors and the Subcommittee for the fiscal year 2020 when calculated together with the extra remuneration (if any) shall not exceed Baht 10,000,000 which is equal to the remuneration for fiscal year 2019. For the extra remuneration, the Remuneration and Nomination Committee will consider and appropriately allocate by taking into account the Company's operational result.
