## Information of the directors' remuneration for fiscal year 2021

The Company stipulates a clear and transparent remuneration policy for the Board of Directors and the Subcommittee. The remuneration is at an appropriate rate comparable to that of the same industry in the same size of business and is suitable for the duties and responsibilities of each director. The directors assigned to perform the duties in the Subcommittees are entitled to receive additional remuneration as a result of the increase in responsibilities. The Remuneration and Nomination Committee will consider the structure and composition of the preliminary remuneration to propose to the Board of Directors Meeting for consideration before proposing the Annual General Meeting of Shareholders for approval.

The Board of Directors agreed upon the proposal of the Remuneration and Nomination Committee and deemed it appropriate to propose to the Annual General Meeting of Shareholders to consider and approve the remuneration for the Board of Directors and the Subcommittees for the fiscal year 2021 when calculated together with the extra remuneration (if any) shall not exceed Baht 12,000,000, increase from the remuneration for fiscal year 2020 (not exceeding Baht 10,000,000) to be in line with the increasing number of the Company's director and the increased duties and responsibilities of the Board of Directors and Subcommittees due to the expansion of the business of the Company Group. For the extra remuneration, the Remuneration and Nomination Committee will consider and appropriately allocate by the responsibilities and Role and the benefits of the performance on duties of the directors.
